# Part A: Pupil premium strategy plan

## Statement of intent

We are 'A caring, cooperative community with high aspirations'. We are a Cooperative Trust Academy and the principles of working cooperatively within and beyond our school is a strength. The school is committed to combating social exclusion. The school provides a broad and balanced curriculum that meets the needs of all pupils irrespective of their background or the challenges they face, with the aim that all our children make good progress and achieve good attainment across all subject areas. The focus of our pupil premium strategy is to support disadvantaged pupils to achieve that goal, including good progress for those who are already high attainers. We continue to work with others in our Trust to refine our bespoke curriculum. Staff are committed to improving the pedagogy and this is a focus of staff CPD.

We will consider the challenges faced by vulnerable pupils, such as those who have a social worker and young carers. The activity we have outlined in this statement is also intended to support their needs, regardless of whether they are disadvantaged or not.

We are focused on ensuring our children have quality first teaching in their class, with a carefully planned focus on key learning, balanced with a curriculum that supports our children's mental and physical health and continues to provide experiences that address deficits in cultural capital.

Quality First teaching is at the heart of our approach, with a focus on areas in which disadvantaged pupils require the most support. Our Pupil progress meetings focus on all our pupils as individuals, discussing and understanding what they need to succeed. This is proven to have the greatest impact on closing the disadvantage attainment gap and at the same time will benefit the non-disadvantaged pupils in our school. Implicit in the intended outcomes detailed below, is the intention that non-disadvantaged pupils' attainment will be sustained and improved alongside progress for their disadvantaged peers. Our strategy is also integral to wider school plans for closing the gap, notably with our School-led tutoring for pupils who need enhanced educational support, including non-disadvantaged pupils.

Through effective teaching in F1, pupils make good progress from significantly low starting points to enter F2 still below their expected stage for their age. Having narrowed the gap, a significant number of children are still working in the 3-4 years band of development in the EYFS curriculum on entry to F2, children's social skills, independence, communication and interaction continues to be a focus in the Early Years. We aim to ensure this does not impact on the children's learning by addressing it directly throughout the whole school. The intention of this report on spending is to illustrate our approach to addressing the needs of the whole child to narrow the attainment gap and set the children up for life. Our approach will be responsive to

common challenges and individual needs, rooted in robust diagnostic assessment, not assumptions about the impact of disadvantage. The approaches we have adopted complement each other to help pupils excel. To ensure they are effective we will:

- Ensure disadvantaged pupils are challenged appropriately to achieve and early intervention is swiftly initiated as needed
- Ensure all children are valued and heard in a safe and caring environment so that they can thrive
- Ensure quality first teaching and high expectations for all pupils, irrespective of disadvantages or challenges children may face, children are encouraged to take responsibility for their learning and have high aspirations for themselves

## Challenges

This details the key challenges to achievement that we have identified among our disadvantaged pupils.

Challenge number	Detail of challenge
1	Assessments, observations, and discussions with pupils indicate underdeveloped oral language skills and vocabulary gaps among many disadvantaged pupils and non disadvantaged pupils with 70% of pupils achieving a GLD in Communication and Language with a gap of -9.4% compared to England's Average. Staff work hard with the children focussing on language development and enrichment across all of the subjects so that children use a wide range of vocabulary in their writing. In Year 6 non disadvantaged pupils achieve the expected standard 74% in writing, well above National (58%).
2	Assessments, observations, and discussions with pupils suggest disadvantaged pupils generally have greater difficulties with phonics than their peers. In Year 1 the gap in phonics for our disadvantaged pupils was -20%. This negatively impacts their development as readers and accessing other areas of the curriculum. Tutoring ensures that the majority of the disadvantaged children meet the expected standard in phonics in Year 2 and by KS2 The percentage of disadvantaged children achieving expected is 67%, 7.4% above the national figure.
3	On entry to Reception class the majority of pupils both non disadvantaged and disadvantaged pupils arrive significantly below age-related expectations in Mathematics (67.8%) compared to national (77.2%). In Year 2, 71% of disadvantaged children reach the expected standard above national (55.8%) and in KS2 70% achieve the expected standard in mathematics which is 11% above national figures.
4	Our assessments, observations and pupil voice indicate that the education and wellbeing of many of our disadvantaged pupils have

	<p>been impacted by partial school closures in the past, to a greater extent than for other pupils. These findings are supported by national studies.</p> <p>This has resulted in significant knowledge gaps and fewer cultural experiences, leading to pupils falling further behind age-related expectations in the earlier years of schooling, especially in language acquisition, phonics, reading and writing.</p>
5	<p>Our assessments, parent and pupil voice, observations and discussions with pupils and families have identified social and emotional issues for many pupils, together with a lack of enrichment opportunities during school closure. These challenges particularly affect disadvantaged pupils, including their attainment and physical and mental well being.</p> <p>Teacher referrals for support for children remain relatively high. Out of 216 disadvantaged pupils there are currently 115 pupils requiring additional support with social and emotional needs, through Advotalk support, School Nurse, Pastoral team, ELSA, bereavement support, Mental Health Practitioner or bespoke Wellness Action Plans.</p>
6	<p>Attendance is consistently above national average. This is as a result of an ongoing commitment from the pastoral team to maintain and sustain good attendance for all pupils.</p> <p>A range of strategies targeted at families with persistent absence reduced the overall percentage of persistent absences to significantly below the LA and below national average. Our assessments and observations indicate that absenteeism is negatively impacting disadvantaged pupils' progress.</p>

## Intended outcomes

## Part B: Review of the previous academic year

### Outcomes for disadvantaged pupils

We have analysed the performance of our school’s disadvantaged pupils during the 2022/23 academic year using key stage 1 and 2 performance data, phonics check results and our own internal assessments.

To help us gauge the performance of our disadvantaged pupils we compared our results to those for disadvantaged and non-disadvantaged pupils at a national and regional level. We also looked at these comparisons using scores for 2022, in order to assess how the performance of our disadvantaged pupils has changed during this period.

Data from tests and assessments suggest that the progress and attainment of the school’s disadvantaged pupils in 2022/23 was in line with our expectations at KS2 and these were all above national figures, showing an upward trend from the previous year.

We identified further approaches to boost outcomes for disadvantaged and All pupils after our evaluation of the year 1 phonics check data this year.

Our observations and assessments demonstrated that pupil behaviour improved last year, but challenges in relation to wellbeing and mental health remain significantly higher than before the pandemic. The impact on disadvantaged pupils has been particularly acute.

We are on course to achieve the outcomes that we set out to achieve by 2024/25, as stated in the Intended Outcomes section above. We have reviewed our strategy plan and made changes to how we intend to use some of our budget this academic year, as set out in the Activity in This Academic Year section above. ## Service pupil premium funding (optional)

As part of the school nurse work- well being discussions supported the children. We identified gaps in service children's education in relation to anxiety and well being. We addressed this with targeted support as well as Advotalk.
<b>The impact of that spending on service pupil premium eligible pupils</b>
Teachers observed improvements in wellbeing amongst service children. Assessments demonstrated progress in subject areas.

### Additional activity

Our pupil premium strategy will be supplemented by additional activity that is not being funded by pupil premium or recovery premium. That will include:

- embedding more effective practice around feedback and pedagogy in the classroom. [EEF evidence](#) demonstrates this has significant benefits for pupils, particularly disadvantaged pupils.
- A range of parental workshops including family links training which supports families and children. This provides parents with a programme to follow which helps to develop a consistent parenting style aligned with our nurturing approach in school. (Studies have shown that The Nurturing Programme is a 10-week parenting programme that improves the emotional health of both adults and children and strengthens family relationships).

- offering a wide range of high-quality extracurricular activities to boost wellbeing, behaviour, attendance, and aspiration. Activities will focus on building life skills such as confidence, resilience, and socialising. Disadvantaged pupils will be encouraged and supported to participate.

### Planning, implementation, and evaluation

In planning our new pupil premium strategy, we evaluated why activity undertaken in previous years had not had the degree of impact that we had expected. We also commissioned a pupil premium review to get an external perspective.

We triangulated evidence from multiple sources of data including assessments, engagement in class book scrutiny, conversations with parents, students and teachers in order to identify the challenges faced by disadvantaged pupils. We also used the EEF's families of schools database and our SASS packs to view the performance of disadvantaged pupils in schools similar to ours.

We looked at a number of reports, studies and research papers about effective use of pupil premium, the impact of disadvantage on education outcomes and how to address challenges to learning presented by socio-economic disadvantage.

We used the [EEF's implementation guidance](#) to help us develop our strategy, particularly the 'explore' phase to help us diagnose specific pupil needs and work out which activities and approaches are likely to work in our school. We will continue to use it through the implementation of activities.

We have put a robust evaluation framework in place for the duration of our three-year approach and will adjust our plan over time to secure better outcomes for pupils.
